# DFA Hong Kong Young Design Talent Award 2022

## Applications Open from Now until 28 June

*Boosting Hong Kong Young Designers and Creative Industries  
by Offering Global Exchange Experiences*

**(20 April 2022, Hong Kong)** The **DFA Hong Kong Young Design Talent Award (DFA HKYDTA)**, which seeks to enlighten Hong Kong young designers' creative thinking with a global perspective and to enrich their worldwide industry experience, is now open for applications until 28 June 2022. Award winners will receive financial support for embarking overseas work or study opportunities to gain global experience and unleash their creative potential.

Organised by Hong Kong Design Centre (HKDC) and supported by Create Hong Kong (CreateHK) of the Government of the Hong Kong Special Administrative Region (HKSAR Government) as the Lead Sponsor, and Hong Kong Design Institute and the School of Design of The Hong Kong Polytechnic University as Sponsors, the DFA HKYDTA provides a sponsorship up to HK\$500,000 for awardee to work at a renowned overseas design company for 6 to 12 months or study at a famed institute abroad for 6 to 18 months. Since 2005, over 120 young designers have gained valuable and eye-opening overseas experiences through this award programme.

“Nurturing young design talent is vital for propelling the design ecosystem and for continuous industry development. The DFA Hong Kong Young Design Talent Award is committed to supporting the growth of Hong Kong young designers. We hope the awardees can explore and discover more possibilities through these overseas experiences, and form part of a revitalised design network that can make substantial contributions to the local creative industries,” said Prof. Eric Yim, Chairman of HKDC.

### **Application Requirements**

Hong Kong permanent residents aged 18 to 35, who are (1) designers with relevant working experience; or (2) 2022 design graduates with Higher Diplomas, Associate Degrees or Bachelor or Master Degrees from accredited local educational institutions; or (3) 2022 design graduates of Master Degrees obtained from accredited overseas educational institutions, with their Bachelor Degrees studied locally and obtained from accredited local educational institutions. Every applicant needs to be nominated by a design-related organisation or a professional.

### **Judging Criteria**

A judging panel comprising locally and internationally recognised professional designers and experts will assess the candidates based on their (1) potential contributions to the design and innovation development in Hong Kong; (2) personal aspirations, talents and achievements in specific fields with potential for continuous development; (3) effectiveness of communication and presentation skills; (4) portfolio of design works and (5) overseas work/ study proposals.

### **The DFA HKYDTA 2021**

The DFA HKYDTA 2021 granted awards to a total of 16 young designers including eight design practitioners and eight design graduates. Among them, 14 awardees will receive a sponsorship totalling up to HK\$5,000,000 for overseas work or study.
